# NATURE CREATION AFFILIATE PROGRAM - TERMS & CONDITIONS

# 1. INTRODUCTION

By participating in the Nature Creation Affiliate Program, you agree to abide by the following terms and conditions. This document outlines the rules and guidelines for affiliates to ensure a transparent and mutually beneficial relationship.

#### 2. ELIGIBILITY CRITERIA

Age Requirement: All participants must be 18 years of age or older to be eligible for the affiliate program.

Payment Method: To receive commission payments, all affiliates are required to have an active PayPal account. It is the affiliate's responsibility to ensure that their PayPal account details are accurate and up-to-date.

## 3. COMMISSION & PAYMENTS

Payments will be made on a monthly basis. The minimum payout amount is \$10. If the affiliate's earnings do not meet the minimum threshold, the amount will be carried over to the next payment cycle.

All payments will be processed exclusively through PayPal. Affiliates are responsible for any fees or charges imposed by PayPal.

## 5. TAX COMPLIANCE FOR HIGH-EARNING AFFILIATES

Affiliates who achieve a commission exceeding \$500 are required to complete a W-9 form in compliance with tax authorities' regulations. This is essential to ensure transparency and adherence to tax obligations. Failure to provide a completed W-9 form may result in a delay or withholding of commission payments until the necessary documentation is received.

#### 5. COOKIE DURATION

• Duration: 60 days. This defines the period during which a customer is linked to an affiliate after clicking their referral link on www.naturecreation.com. If a customer makes a purchase within this 60-day window, the affiliate will earn a commission for that sale.

#### 6. RESPONSIBILITIES & CONDUCT

Affiliates must promote Nature Creation products in a manner that is ethical, honest, and in compliance with all applicable laws and regulations.

Affiliates are prohibited from making false or misleading statements about Nature Creation products.

The use of spam or any unsolicited promotional methods is strictly prohibited.

#### 7. TERMINATION

Nature Creation reserves the right to terminate an affiliate's participation in the program for any breach of these terms and conditions or for any conduct deemed harmful or inappropriate.

#### 8. CHANGES TO TERMS & CONDITIONS

Nature Creation may update these terms and conditions from time to time. Affiliates will be notified of any significant changes and are responsible for regularly reviewing the terms.
